PURPOSE

Fountain-Fort Carson School District 8 is committed to raising academic achievement. The Summer Learning Institute (SLI) extends the educational program into the summer months, providing remediation and credit recovery opportunities for students.

REGISTRATION

Registration will begin **Monday, April 8, 2019** and conclude Tuesday, June 4, 2019. All students must pay a 25 % deposit at the time of registration. Classes and sections will be filled on a first-come, first-served basis.

Final registration will be Friday, June 14, 2019 from 8:00 a.m. – 10:00 a.m. at Fountain Middle School, 515 North Santa Fe Avenue, Fountain, CO 80817.

All middle school and high school classes will be held at Fountain Middle School, 515 North Santa Fe Avenue, Fountain, CO 80817.

- **A 25% deposit is required at the time of registration. This will be applied toward the cost of classes.**
- **The remaining balance is due in full by **Friday, June 14, 2019.****
- Students enrolled after June 14, 2019 will be charged a late fee of \$25.
- Students not enrolled in Fountain-Fort Carson School District 8 will pay \$120.00 for each class.
- Once the District has entered fees in the Parent Portal, payments can be made through RevTrak. There is a \$2.00 convenience fee.

GENERAL EXPECTATIONS

Except as noted below, students and staff are expected to follow the same rules, regulations and policies established by School District 8 during the regular school year (this includes dress code). If there are any changes or additions to these policies, the SLI Principal, Aaron Coons, will inform students and parents as soon as possible. Should you have any questions, please contact the SLI Principal. Please ensure updated contact information is on file for your student, in case of an emergency or if a staff member needs to contact you.

ATTENDANCE

- **Absences – SLI makes no distinction between excused and unexcused absences.** If a student is not in the classroom, he/she will be marked absent. Students may be absent from class **two times**. **Upon the third absence, the student will be dropped from the program.**
- **Tardies –** A student late to class is marked tardy during the first 15 minutes of class. If a student misses more than 15 minutes, he/she will be marked absent. **Three tardies will count as one absence.**
- **ATTENDANCE POLICIES WILL BE STRICTLY ENFORCED!**

BEHAVIOR

- Expectations for behavior and attitude are the same as during the regular school year. Any behavior that detracts from the teaching/learning experience will not be tolerated. Teachers may refer students to the SLI Principal. Upon the **third referral**, the student will be **dropped from the SLI program.**
- The principal of the SLI Program has the right to drop the student on the **first or second referral if warranted.**
- **Refunds will not be given for students who are dismissed for discipline or attendance infractions.**
- Students **will be held responsible** for the use and care of school laptops and are subject to fines and disciplinary action for improper use.
- Food and drink are not allowed in the classrooms. Clear water bottles are allowed.



BUS SCHEDULE

Adjustments may need to be made during the year to best utilize buses. Written notices will be sent home with students 3 days prior to any bus schedule changes. Bus students will abide by all rules and regulations. Please be sure to review them with your student. Infractions of these rules may warrant suspension from transportation provided by the district.
